**Notes:**

- 1) The listed course fees are in Singapore dollars, nett of government subsidy, where applicable and exclusive of GST, which will be subject to prevailing GST.
- 2) The above estimated tuition fees are for the entire degree programme (inclusive of 10 cu of SUSS Core courses). The actual total tuition fees payable will be based on the type of courses taken by the students.
- 3) The annual tuition fee for a particular programme can be estimated by dividing the programme fee by the number of years that a student may take to complete the programme.  
For example, if a Singapore Citizen student takes 4 years out of the maximum 8-year candidature to complete the Accountancy programme, the estimated annual tuition fee is about \$4,928.75 (before GST).
- 4) The programme fees for Art/Music/Sports and Physical Education programmes are estimated based on 40cu of minor courses (non-lab) in the same discipline.
- 5) The programme fees are reviewed annually and may be revised. SUSS reserves the right to adjust the programme fees without prior notice.
- 6) All part-time undergraduate students will pay an annual miscellaneous fee of S\$20 (subject to prevailing GST). The miscellaneous fees consists of items such as CLASS copyright licensing fees, computer fees, etc.
