Notes:

- 1) The above estimated tuition fees are for the entire degree programme (inclusive of 10 cu of University Core courses). The actual total tuition fees payable will be based on the type of courses taken by the students.
- 2) The annual tuition fee for a particular programme can be estimated by dividing the programme fee by the number of years that a student may take to complete the programme.
For example, if a Singapore Citizen student takes 4 years out of the maximum 8-year candidature to complete the Accountancy programme, the estimated annual tuition fee is about \$5,208.75
- 3) The listed programme fees are nett of government subsidy, where applicable and inclusive of GST.
- 4) The programme fees are reviewed annually and may be revised. SUSS reserves the right to adjust the programme fees without prior notice.
