

## SUSS – PA SPONSORSHIP

### TERMS AND CONDITIONS

- The Sponsorship is open to new and current SUSS students pursuing part-time undergraduate programmes, Bachelor of Laws, or graduate programmes (Master's, PhD and Doctoral programmes only).
- The Sponsorship is open to grassroots leaders with People's Association (PA) and/or its associated organisations as well as staff of PA. Applicants must continue to serve PA throughout the duration of the programme or the sponsorship will be immediately revoked.
- Applicants must be Singapore citizens or Permanent residents, and must meet the following criteria:
  - Possess good academic and co-curricular activities records, strong language skills and demonstrate leadership qualities.
  - Applicants who are currently applying for admission to the undergraduate programmes (or existing undergraduate students) must not already be degree holders.
  - Being nominated by Citizens' Consultative Committee/Community Centre/Club Management Committee Chairman or General Manager (CDC), and are endorsed by Adviser/Mayor.
  - Have completed at least three years of continuous service in any GRO/CDC immediately prior to the nomination.
  - Are deserving, qualified and made significant contributions to the GRO/CDC/community.
  - Possess high potential to hold key/senior positions in grassroots organisations (GROs)/CDCs.
- The Sponsorship covers course fees for the entire programme of study, up to the values indicated below:

5. Sponsorship recipients are not required to serve a bond with the SUSS or PA.
6. Applicants must meet the admission requirements for the applied course of study. Prospective students must separately seek admission to the programme and must be accepted for admission before being awarded the Sponsorship.
7. Prospective students must separately submit the online Admission Application with supporting documents and S\$64.20 (inclusive of GST) application fee (non-refundable) to SUSS.
8. Applicants are allowed to apply for only one Sponsorship or Scholarship at any one time.
9. The Sponsorship may not, without the prior approval of SUSS, be held concurrently with any other awards.
10. The recipient is required to sit for all examinations, complete the programme within the prescribed time and conform to regulations, instructions and discipline in force for the respective programme. In addition, for continuation of the sponsorship, the recipient is required to maintain at least a Cumulative Grade Point Average (CGPA) of 3.0 for part-time undergraduate programmes, or a CGPA of 3.5 for the Bachelor of Laws, or a CGPA of 4.0 for graduate programmes.
11. SUSS reserves the right to withdraw or suspend the sponsorship at any time if, in its opinion, the recipient's conduct or academic performance has not been satisfactory.
12. SUSS and PA reserve the right to amend the terms and conditions for the Sponsorship award at their sole discretion.
13. Applicants are required to submit copies of educational certificates, transcripts, pay slip and other supporting documents together with the sponsorship application. Otherwise, the application would be considered incomplete and will not be processed.
14. Sponsorship application for **January semester / July semester** must be submitted by **30 September / 31 March** respectively. Recipients are not allowed to request for deferment of the sponsorship award.
15. Shortlisted applicants will be notified to attend an interview at SUSS by **end October for January semester** and **end April for July semester**. **The decision of the SUSS and PA on the selection of Sponsorship candidates is final and no appeal will be entertained.**

A separate letter and agreement with the detailed terms and conditions (including the above terms and conditions) and others relating to the course of study will be given to all successful applicants.
