

SUSS-STTA SPORTS LEADER SPONSORSHIP

TERMS AND CONDITIONS

1. The Sponsorship is open to new and current SUSS students pursuing part-time undergraduate programmes, Bachelor of Laws, or graduate programmes (Master's, PhD and Doctoral programmes only).
2. The Sponsorship is open to eligible national players nominated by the Singapore Table Tennis Association (STTA).
3. Nominated national players must be Singapore citizens who fulfil the selection criteria set by SUSS and STTA. They must meet the admission requirements for the applied course of study.
4. Applicants who are currently applying for admission to the undergraduate programmes (or existing undergraduate students) must not already be degree holders.
5. The Sponsorship covers course fees for the entire programme of study, up to the values indicated below:

* For PhD / Doctoral programmes, 50% sponsorship is applicable only to coursework part of the programme

6. This sponsorship may not, without the prior approval of SUSS, be held concurrently with any other Scholarship or Sponsorship awards.

7. Successful recipients are required to sign a sponsorship agreement with SUSS, and have to conform to the terms and conditions spelt out in the Sponsorship agreement. SUSS and STTA reserve the right to amend the terms and conditions for the Sponsorship award at their sole discretion without prior notice.
8. SUSS reserves the right to withdraw or suspend the Sponsorship at any time if, in its opinion, the recipient's conduct or academic performance has not been satisfactory.
9. Sponsorship recipients are not required to serve a bond with the SUSS or STTA.
10. Nominated national players must submit the online Admission Application and Sponsorship Application (together with supporting documents) to SUSS, with a non-refundable application fee of S\$64.20 (inclusive of GST). Application submitted without the required documents will be considered incomplete and will not be processed.
11. Admission and Sponsorship applications must be submitted by **30 September (for January intake)** and **31 March (for July intake)**. Shortlisted applicants will be notified to attend an interview at SUSS by **end October (for January intake)** and **end April (for July intake)**. Sponsorship recipients are not allowed to request for deferment of the sponsorship award.
12. The decision of the SUSS and STTA on the selection of Sponsorship candidates is final and no appeal will be entertained.

A separate letter and agreement with the detailed terms and conditions (including the above terms and conditions) and others relating to the course of study will be given to all successful applicants.
