- From July 2022 semester, all new graduate programme students who are Singapore Citizens, Singapore Permanent Residents or other residents will pay an annual miscellaneous fee of \$20 (subject to prevailing GST). The miscellaneous fee consists of items such as CLASS copyright licensing fees, computer fees, etc.
- All international students are required to hold a valid [Student's Pass](#) issued by the Singapore Immigration & Checkpoints Authority (ICA) for their studies at SUSS, and will pay an annual miscellaneous fee of \$380 (subject to prevailing GST). **For Doctor of Business Administration (DBA) only**

1. DBA programme fees consist of both course fees and dissertation fees
2. DBA fees will be collected on a semester basis. Students will be required to pay \$15,750 per semester (SC/PR)/\$18,900 per semester (Other Residents) for the first 4 semesters and \$13,500 per semester (SC/PR)/\$16,200 (Other Residents) for the 5th semester and 6th semester.
3. Course fees is estimated based on 40cu of coursework and applicable to students from January 2020 intake onwards.
4. The dissertation fee payment can be fully made upon commencement of DBA candidature or via instalments over the first four semesters of the DBA candidature. (DBA candidature is officially granted upon completion of all courses and passing of the Doctoral Qualifying Exam).
5. In the event that a DBA candidate requires more than four semesters to complete the dissertation, he/she shall pay an additional \$10,000 (exclusive of prevailing GST) from the 6th year onwards until he/she completes the dissertation or reaches the maximum allowable candidature.
6. All outstanding fees must be fully paid for the DBA candidature to be considered for graduation.

**For Doctor of Philosophy (PhD)**

7. Course fees is estimated based on 40cu of coursework.
8. In the event that a PhD student takes courses from SMU and NTU, they will pay prevailing fees as set out by these institutions.
9. The minimum candidature is 3 years, if we assume that the candidate takes 1 year to complete coursework and 2 years to complete dissertation.
10. The maximum candidature is 7 years, if we assume that the candidate takes 1 year to complete coursework and 6 years to complete dissertation.

**For Doctor of Philosophy (Engineering)**

11. Course fees is estimated based on 40cu coursework.
12. The minimum candidature is 3 years, if we assume that the candidate takes 1 year to complete coursework and 2 years to complete dissertation.
13. The maximum candidature is 7 years, if we assume that the candidate takes 1 year to complete coursework and 6 years to complete dissertation.

**For Master of Applied Research in Social Sciences and Master of Engineering**

14. Course fees is estimated based on 20cu coursework.
15. The minimum candidature is 2 years, if we assume that the candidate takes 1 year to complete coursework and 1 year to complete thesis.
16. The maximum candidature is 4 years, if we assume that the candidate takes 1 year to complete coursework and 3 years to complete thesis.
