- The tuition fee payable each semester is dependent on the number of courses the student takes in each semester. The tuition fee does not include textbooks and fee for other items specified by Singapore University of Social Sciences (SUSS) from time to time.
- QE refers to Qualifying Exam.
- All fees stated are in Singapore dollars, and exclusive of prevailing GST.
- From July 2022 semester, all new graduate programme students who are Singapore Citizens, Singapore Permanent Residents or other residents will pay an annual miscellaneous fee of \$20 (subject to prevailing GST). The miscellaneous fee consists of items such as CLASS copyright licensing fees, computer fees, etc.

All international students are required to hold a valid <u>Student's Pass</u> issued by the Singapore Immigration & Checkpoints Authority (ICA) for their studies at SUSS, and will pay an annual miscellaneous fee of \$380 (subject to prevailing GST). The miscellaneous fee consists of items such as CLASS copyright licensing fees, computer fees, student insurance, etc. For more information on the Student Insurance Scheme, please click <u>here</u>.

For Doctor of Business Administration (DBA) only

- 1. Course fees is estimated based on 40cu of coursework and applicable to students from January 2020 intakeonwards.
- The dissertation fee is due upon DBA candidature being granted (DBA candidature is officially granted upon completion of all courses and passing the Doctoral Qualifying Exam). Payment can be made fully upon starting DBA candidature or via instalments over the first four semesters of the DBA candidature.
- 3. In the event that a DBA candidate requires more than four semesters to complete the dissertation, he/she shall pay an additional \$2,500 (exclusive of prevailing GST) per semester from the 5th semester of DBA candidature onwards until he/she completes the dissertation or reaches the maximum allowable candidature.
- 4. All outstanding fees must be fully paid for the DBA candidature to be considered forgraduation.



For Doctor of Philosophy (PhD)

- Course fees is estimated based on 40cu of coursework. 5.

- In the event that a PhD student takes courses from SMU and NTU, they will pay prevailing fees as set out by these institutions. The minimum candidature is 3 years, if we assume that the candidate takes 1 year to complete coursework and 2 years to complete dissertation. The maximum candidature is 7 years, if we assume that the candidate takes 1 year to complete coursework and 6 years to complete dissertation. 8

For Doctor of Philosophy (Engineering)

- Course fees is estimated based on 40cu coursework. 9
- The minimum candidature is 3 years, if we assume that the candidate takes 1 year to complete coursework and 2 years to complete dissertation. 10.
- The maximum candidature is 7 years, if we assume that the candidate takes 1 year to complete coursework and 6 years to complete dissertation. 11.

For Master of Engineering

- Course fees is estimated based on 20cu coursework. 12.
- The minimum candidature is 2 years, if we assume that the candidate takes 1 year to complete coursework and 1 year to complete thesis. 13.
- 14. The maximum candidature is 4 years, if we assume that the candidate takes 1 year to complete coursework and 3 years to complete thesis.
