Event Terms and Conditions

I have read, understand and agree to the Terms and Conditions of the SLYC2026 made available to me. I undertake that my child/ward will abide by the Terms and Conditions and understand that any breach may result in my child/ward’s disqualification, forfeiture of prizes, removal from the SLYC2026 and disqualification from future events organised by SUSS.

Release and Indemnification

I understand that there is no guarantee that my child's/ward's participation in the SLYC2026 is free of risk of personal injury or property damage or loss. To the maximum extent permissible by law, I hereby release SUSS, its officers, employees, SLYC2026 partners, sponsors, suppliers, agents and volunteers (collectively, the "Released Parties"), from and against any and all claims, demands, suits, judgments, damages, actions, and liabilities of every name and nature whatsoever, whenever occurring, whether known or unknown, contingent or fixed, at law or in equity, that my child/ward may suffer at any time arising from or in conjunction with his/her participation in the SLYC2026, including any injury or harm to my child/ward, my child's/ward's death, or loss or damage to my child's/ward's property and I agree to defend, indemnify, and save the Released Parties harmless from and against any and all such liabilities.

I acknowledge that the Released Parties are NOT responsible for the errors, omissions, acts, or failures to act of any third party or entity conducting a specific event or activity on behalf of SUSS.

If any provision of this Waiver and Release is found to be void or unenforceable in a judicial proceeding, such provision shall be severed and shall be inoperative, and the remainder of this Waiver and Release shall remain operative and binding on all Released Parties. THE RELEASED PARTIES ARE NOT LIABLE FOR ANY CONSEQUENTIAL, PUNITIVE, SECONDARY, SPECULATIVE, SPECIAL OR INCIDENTAL DAMAGES.

Personal Data

By registering for SLYC2026, you agree that SUSS may collect, use and disclose you and/or your child/ward's personal data (including any visual images, photographs and/or videos of yourself captured during SLYC2026) for the purposes of (a) processing your child/ward's registration; (b) administering and planning your child/ward's participation in SLYC2026; (c) maintaining SLYC2026 participants' database; (d) processing your payment for SLYC2026 (if any); (e) responding to you or your child/ward's queries about SLYC2026; (f) obtaining you or your child/ward's feedback on your child/ward's SLYC2026 experience; and (g) sending updates and news on future events organised by SUSS and/or their partner organisations which may be of interest to you. You further agree that images of your child/ward in video recordings or photographs taken at SLYC2026 ("**Images**") may be used for other marketing and publicity-related purposes in SUSS publications including on SUSS' website or other websites and that copyright in the Images belong to SUSS. If you request SUSS to cease using the Images at any time, they will not be used in future publications but may continue to appear in publications already in circulation. It may be necessary for SUSS to disclose you or your child/ward's personal data with our agents/service providers in relation to the stated purposes as well as third parties funding and/or jointly organising SLYC2026.
